BY CHECKING THE "I HAVE READ AND AGREE TO THE MEMBERSHIP AGREEMENT INFORMATION CONTAINED IN THE TERMS AND CONDITIONS OF USE" BOX AND SUBMITTING THE REGISTRATION FORM OR ACCESSING, USING OR INSTALLING ANY PART OF THE SERVICE, YOU EXPRESSLY AGREE AND CONSENT TO BE BOUND BY ALL OF THE TERMS AND CONDITIONS OF THIS AGREEMENT.

By submitting a membership application, you further agree that you are 18 years of age or older, and are a resident of one of the following U.S. States, or Other Jurisdictions listed immediately below this paragraph. You agree to be bound by the Laws of Costa Rica, and the Laws of The United States, and by the Laws of the U.S. State or other jurisdiction in which you reside:

Entry into any Book Your Bet Club service is only available to residents of the following U.S. States: Alaska, Arizona, California, Connecticut, Delaware, Florida, Hawaii, Illinois, Iowa, Kansas, Kentucky, Louisiana, Maine, Massachusetts, Mississippi, Nebraska, Nevada, New Hampshire, New Jersey, New Mexico, New York, North Carolina, Oregon, Pennsylvania, Rhode Island, Utah, Vermont, Virginia, West Virginia, Wisconsin, Wyoming, District of Columbia. Book Your Bet Club services are also available to residents of: Argentina, Australia, Brazil, Canada, Egypt, Finland, France, Germany, India, Mexico, Norway, South Africa, Spain, Sweden, Switzerland and the United Kingdom.

1. Accounts: There are two types of Accounts offered; Non-Activated, and Activated.

- A. Non-Activated Accounts:** There are no charges or costs associated with any Book Your Bet Club account upon initial application, and any person who completes the application will be provided with the necessary documentation to allow immediate play for free, in the play for fun only mode. A Book Your Bet Club membership will allow access to all features of any Book Your Bet site, using play money, and all New non-activated accounts will terminate 45 days from their conception, unless Activated by the Book Your Bet Club Member. Non-Activated account holders cannot participate in any tournament or contest where prizes or points with value are offered, and may not receive any prizes or rewards in any form, as a result of their activity.
- B. Activated Accounts:** Activated accounts are eligible to enter Tournaments and Contests and are also eligible to receive prizes offered in those Tournaments and Contests. Activated accounts are subject to Membership Fees which include an Annual Membership Fee and Monthly Membership Dues. These fees are outlined in the Cost of Membership section at www.bookyourbet.com, and are non-refundable.

Activation conditions vary depending upon the jurisdiction in which the Book Your Bet Club member resides, and fees and conditions specific to the members jurisdiction, along with an invoice for those

fees will be sent via e-mail, when the Book Your Bet Club member requests account activation, and Atlantic West Management S.A. and the Book Your Bet Club accepts the activation request.

2. Use of Play Money and Poker Points and Tournament Ratings:

- A. USE OF PLAY MONEY:** Book Your Bet Play Money is the currency used in Ring Play (located in the "Poker Rooms") and/or as the buy ins and payouts for some tournaments.
- i. All Book Your Bet Club Members, receive \$10,000 in Play Money when they open their account. An additional \$1,000 in play money is added to all Book Your Bet Club Member accounts upon log in to the Book Your Bet Poker game room, once every calendar day. An additional \$1,000 in play money can be acquired once every calendar day by going to the "More Chips" section of the Book Your Bet Poker game client and clicking on 'Get more Play Money'. If the player doesn't log in and/or claim that day's \$1,000 in play money, it is forfeited and not recoverable on subsequent days. Calendar day is defined by 12:01 am (GMT-5) to, 12:00 am (GMT-5) the following day.
 - ii. Play Money is a virtual currency (Play Money Chips) used for game play in ring games (located in the "Poker Room") and/or as the buy-ins and payouts for some tournaments. Play Money may NOT be purchased using real-world currency, but is available to Book Your Bet Club Members by virtue of their membership, and by successfully completing certain special offers or promotions. Play Money is for entertainment only. The Book Your Bet Club may charge membership fees for the license to use its Play Money or may award and/or distribute its Play Money at no charge, at Atlantic West Management's and the Book Your Bet Club's sole discretion.
 - iii. Use of any virtual currency, including, but not limited to Book Your Bet Play Money, available at <http://www.bookyourbet.com> is use of a limited, non-transferable, revocable license. The license may be terminated immediately if your account is terminated for any reason, in Atlantic West Management's sole and absolute discretion, or if Atlantic West Management discontinues providing and/or dramatically alters the services on the Site.
 - iv. Play Money can be awarded based on successful completion of special offers or promotions at Book Your Bet Club's sole discretion. These awards are dependent on successful completion of said offers, as defined by the company or affiliate providing the offer or promotion.
 - v. Book Your Bet Play Money chips are for entertainment purposes only and are not redeemable or transferable for real-world funds or prizes whatsoever and cannot be used for any purpose except as provided in this section. Play Money is not redeemable for any amount of real-world currency or monetary value from Atlantic West Management S.A. and the Book Your Bet Club at any time.
 - vi. You agree that all acquisitions of virtual currency available to Book Your Bet Club Members are final. No refunds will be given for virtual currency purchases. You agree that virtual currency will be forfeited if your account is terminated for any reason, in Book Your Bet Club's sole and absolute discretion, or if Book Your Bet Club discontinues providing and/or dramatically alters the services on the Site.
 - vii. You agree that the acquisition of virtual currency available on <http://www.bookyourbet.com> is the use of a limited license and that you have no property interest in the virtual currency or virtual items.
 - viii. You agree that any awards or granting of Play Money, or any virtual currency, on <http://www.bookyourbet.com> received from completing a special offer or promotion are dependent upon successful completion of said offer or promotion.

- ix. You agree that the Book Your Bet Club has the right to manage, control, modify and/or eliminate Play Money as it sees fit at its sole discretion. Further, you agree that the Book Your Bet Club will have no liability to you based on the Book Your Bet Club's exercise of these rights.

B. USE OF POKER POINTS: Poker Points are awarded as a result of play in Multi-table Tournaments and Sit & Go Tournaments as set forth in these terms and conditions. Poker Points can only be used to enter the Basic Multi-Table Tournaments (BMTT), Basic Sit & Go Tournaments (BSNGT), Basic Instant Cash Tournaments (BICT), Basic Weekly Cash Tournaments, Book Your Bet Club Multi-Table Tournaments (PMTT), Book Your Bet Club Sit & Go Tournaments (SMTT), Book Your Bet Club Instant Cash Tournaments and Book Your Bet Club Weekly Cash Tournaments (as defined in section 3) as follows:

- i. Book Your Bet Club Members receive 500 Poker Points when they open their account, regardless of method of entry. If a member's account is below 500 Poker Points at 2:01 AM Eastern Time (GMT-5) of any calendar day, the account will automatically be reset to 500 Poker Points between 2:01 AM Eastern Time and 6:01 AM Eastern Time (GMT-5) on that day.
- ii. **Poker Points cannot be used in Ring Play.**
- iii. Poker Points have no cash value whatsoever and cannot be used for any purpose except as provided in this Section.
- iv. Once Poker Points are used to enter any event as described in Section 3, each entrant will be given play chips for use in that tournament only, normally but not always the same amount of play chips depending on the structure of the tournament. These play chips cannot be used for any purpose except for the tournament in which they were used and are extinguished at the end of the tournament.

C. TOURNAMENT RATINGS: For entry into Ratings-Based Tournaments, Book Your Bet Club Members are allowed entry only into the tournament specific to their rating level at the time of registration regardless of their method of entry. All Book Your Bet Club Members, regardless of their membership status, can obtain their current Tournament Rating by sending an email to support@bookyourbet.com and requesting this information.

- i. Book Your Bet Play Chips = Play For Fun (Ring Games)
- ii. Poker Points = Play for Real (Tournaments)

3. Description of Play:

A. Poker Room Games: Book Your Bet Club Members may play any of the following six (6) games in the poker room (a description of each game is listed below):

- i. Texas Hold'em
- ii. Texas Hold'em Double flop
- iii. 7 Card Stud
- iv. 7 Card Hi/Lo
- v. Omaha
- vi. Omaha Hi/Lo

- B.** Ring Play is constantly available in the Poker Room. The amount of Play Money required in buy in to a particular Ring game will be posted at each table on the site. No Poker Points will be awarded for play in Ring Play games.
- i. Ring play can be found in the "Poker Rooms" within the Book Your Bet Poker Game Client. Each table within the Poker Rooms has different table bet limits for beginners, intermediates and advanced Book Your Bet Club Members. Generally, the higher the table limit, the more difficult the table. Additional tables offer no-limit poker with set Book Your Bet Play Money buy-ins.
- C.** Open Tournaments (BSNGT), (BMTT) as defined below) and Ring Play on <http://www.bookyourbet.com> and the Book Your Bet Poker Game Client are available to anyone who registers on the Site and becomes a member, completes the registration process at <http://www.bookyourbet.com>, meets the qualifications set forth herein and affirmatively accepts these terms of use and the associated privacy policy.
- i. Basic Sit & Go Tournaments (BSNGT) are ongoing tournaments occurring in the Poker Room consisting of exactly 10 Book Your Bet Club Members. At least one Basic Sit & Go Tournament will be available or in progress in the Poker Room at any time. A Basic Sit & Go Tournament will not begin until exactly 10 Book Your Bet Club Members register for the tournament. (NOT AVAILBLE FOR MORE THAN 10 Book Your Bet Club Members)
 - ii. Basic Multi-Table Tournaments (BMTT) are scheduled tournaments in the Poker Room. No additional Book Your Bet Club Members will be entered into a particular tournament once the maximum number of Book Your Bet Club Members is reached. Entry is on a first come, first served basis. Provided that the minimum number of Book Your Bet Club Members enters, a Basic Multi-Table Tournament will be held about once every 30 minutes. The Book Your Bet Club will not conduct a Basic Multi-Table Tournament unless the minimum number of Book Your Bet Club Members registers to play that tournament.
- D.** Book Your Bet Club tournaments (BYBSNGT) and (BYBMTT), as defined below) on <http://www.bookyourbet.com> are available to Book Your Bet Club members and mail-in entrants.
- i. Book Your Bet Club Multi-table Tournaments (BYBMTT) are scheduled tournaments in the Poker Room. No additional Book Your Bet Club Members will be entered into a particular tournament once the maximum number of Book Your Bet Club Members is reached. Entry is on a first come, first served basis. Provided that the minimum number of players enters, a (BYBMTT) will be held about once every 10 minutes. Poker Points will be required to buy in to (participate in) a particular (BYBMTT). The Book Your Bet Club will not conduct a (BYBMTT) unless the minimum number of Book Your Bet Club Members, register to play that tournament.
- E.** Daily Cash Tournaments are scheduled tournaments that have a maximum of 2,000 Book Your Bet Club Members (note that this maximum is subject to change without notice to Book Your Bet Club Members). No additional Book Your Bet Club Members will be entered into a particular tournament once the maximum number of Book Your Bet Club Members is reached. Entry is on a first come, first served basis. Provided that the minimum number of Book Your Bet Club Members enters, a Daily Cash Tournament will be held about forty times each day. The exact times of each Daily Cash Tournament will be posted on the site. Poker Points may be required to buy in to (participate in) a Daily Cash Tournament.
- F.** Weekly Cash Tournaments - Entry requirements for Weekly Cash Tournaments are as follows: Entry into the Weekly Cash Tournament Finals requires Book Your Bet Club Members to finish in the top 5 or 10 in at least one Weekly Cash Tournament Qualifier (depending on the structure of the Qualifier) or buy in

directly prior to the event during the registration period for the required amount of Poker Points. Entry into each Weekly Cash Tournament Qualifier may require Poker Points to buy in (participate) depending on the structure of the Qualifier. The top 5 or 10 finishers in each Weekly Cash Tournament Qualifier will win a seat at that week's Weekly Cash Tournament Finals.

- i. Weekly Cash Tournament Qualifiers are scheduled tournaments in the Poker Room. Weekly Cash Tournament Qualifiers will be held throughout each week on the times and dates to be posted in the lobby of the poker room. No additional Book Your Bet Club Members will be entered into a particular tournament once the maximum number of Book Your Bet Club Members is reached. Entry is on a first come, first served basis. If the number of Book Your Bet Club Members registered for a particular Weekly Cash Tournament Qualifier is less than 2, that particular Weekly Cash Tournament Qualifier will not be run.
- ii. Book Your Bet Club Members can enter as many Weekly Cash Tournament Qualifiers as they have Poker Points to meet the entry requirements but can earn only one (1) entry into the Weekly Cash Tournament Finals, regardless of how many times they qualify.
- iii. No cash prizes will be given out for the winners of the Weekly Cash Qualifier Tournaments.
- iv. Weekly Cash Tournament Finals are scheduled tournaments in the Poker Room. Weekly Cash Tournament Finals will be held each week on the time and date to be posted in the lobby of the poker room. The Weekly Cash Tournament Finals have a maximum of 2,000 Book Your Bet Club Members. Book Your Bet Club Members that have not qualified for the Weekly Cash Tournament Finals must monitor the Site for the starting time of the Weekly Cash Tournament Final and timely register for the event at least 15 minutes before the time and date that it is scheduled to commence. If a player fails to timely register, player forfeits entry to the tournament.

4. **General Rules Applicable to All Tournaments:**

- A. All tournaments will begin at the time designated in the tournament details, which may be found in the Book Your Bet Poker Game Client lobby.
- B. Each player will be assigned a seat and he/she may not change his/her assigned seat.
- C. Book Your Bet Club Members may un-register from a tournament up to the time it starts OR until the tournament has reached capacity.
- D. There is a deal for the button at the start of the tournament; high card plays the button for the first hand.
- E. The button moves in the conventional clockwise manner so that no player receives the button twice in a row. Occasionally, a player may become the button without having played in the blinds due to other Book Your Bet Club Member being eliminated (this commonly occurs in online tournaments due to technical software issues). This may happen to any player during the course of a tournament and therefore creates no long-term advantage.
- F. If a player registers for any tournament and is inactive (does not participate) during the first blind level, the player may be removed from the tournament at the Book Your Bet Club's discretion and no buy in will be refunded.

- G. If a player registers for any tournament and sits out 11 consecutive hands at any time, the player will be removed from the tournament and no buy in will be refunded.
- H. If two (2) Book Your Bet Club Members should be eliminated simultaneously, the player with the largest number of chips at the beginning of the hand will be designated as having finished higher. It is impossible for two (2) people to be eliminated simultaneously when going heads up at the final table.
- I. If two (2) or more Book Your Bet Club Members should be eliminated simultaneously with the same amount of chips at the beginning of the hand, these Book Your Bet Club Member will tie and split the prize amount awarded to all places affected.
- J. When a tournament is down to the last two (2) Book Your Bet Club Members, the button will post the small blind and be first to act in the initial round. The big blind will then be first to act in the following rounds.
- K. The tournament finishes when one (1) player has won all the tournament chips and is declared the winner.
- L. Any play deemed unethical by the Sponsor in its sole discretion (including, without limitation, team play, soft play or chip dumping) will result in the applicable player(s) being disqualified from the tournament.
- M. As Book Your Bet Club Members are eliminated over the course of a tournament, tables will be consolidated to keep a full complement of Book Your Bet Club Members may be forced to post the blinds when arriving at a new table. Table reassignments are an inherent part of tournaments and apply equally to all Book Your Bet Club Members.
- N. Book Your Bet Club Members and observers are asked to use the chat function in a friendly and considerate way. At no time are Book Your Bet Club Members and observers allowed to discuss or comment on live hands. At no time are Book Your Bet Club Members and observers allowed to chat in any language other than English.
- O. Internet issues may cause server interruptions and Sponsor will endeavor to limit such interruptions during a tournament, but Sponsor does not assume responsibility for any such problems. In the event of a player disconnection, Sponsor will allow extra time for the disconnected player to reconnect in the later rounds of a tournament. If a player chooses to sit out or is unable to reconnect, he/she will still have cards dealt to him/her and will automatically post blinds and antes. Book Your Bet Club Members that are unable to reconnect during the allotted time will have their hand automatically folded.
- P. In the 4th round of the tournament, and in all consecutive rounds, all the players must pay an ante amount that is equal to 1/8th of the big blind. This amount is added to the main pot.
- Q. In all Free Roll Tournaments, all players that do not play any hand in the first round will forfeit most of the remaining chips (retaining only 20 chips).

5. **PLAYER ELIGIBILITY:**
